Purpose

The purpose of this Agreement is to enhance academic interest and to promote research and continuing education between the students of Sibar Institute of Dental Sciences, Guntur, hereby named as Party 1 and Chebrolu Hanumaiah Institute of Pharmaceutical Sciences, Guntur hereby named as Party 2.

Types of Cooperation

Through this memorandum, both Parties affirm the value of collaboration and agree to promote the following activities:

1. To identify and utilize the expertise of senior faculty members for advancement in academic and research activities.
2. To identify the areas of mutual academic interest for mutual development
3. Guidance in infrastructural development.
4. Guidance in organizing student development activities like seminars, conferences, workshops etc.
5. Fostering in research activities in both the institutes.
6. Any other activities as mutually agreed.

This Agreement places no financial obligations or supplementary funding commitments on either Party and involves no legal binding between the two parties. These activities will be defined through separate program agreements that detail the commitment of resources (financial or otherwise) required by each Institution. Subsequent program agreements must be approved in writing by the authorized representatives of each institution.

Terms

This agreement will become effective upon the date of signature by both Parties. It shall remain valid for a period of five (5) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both Parties. This Agreement may be terminated by either Party with advance written notice of at least thirty (30) days. The agreement may be extended by mutual consent of the two Parties after the five-year period, and it must be renewed in writing.


Whereas the 1st Party IRCF being a division of Indian Society of Anaesthesiologists, which is registered as academic body, non-profit organization of Anaesthesiologists .

The 1st Party, Indian Resuscitation Council Federation, hereafter called IRCF has developed and prepared the Indian Resuscitation Guidelines, which were peer reviewed and published in an indexed journal; Indian Journal of Anaesthesia. These resuscitation guidelines are suitable for a country like India, where the emergency medical system is not well developed. To give training to medics, paramedics, school children and laymen. The 1st party is suggesting to establish Comprehensive Resuscitation Training Centers (CRTC) through which they can impart training all over India.


The main objective of 1st Party IRCF is to make Every Citizen A Life Saver to decrease the number of preventable deaths due to sudden cardiac arrest.

Whereas the 2nd Party who is desirous to establish Comprehensive Resuscitation Training Centre hereafter called (CRTC) with an interest of training all the citizens and came into contact with the 1st Party, IRCF, following the IRCF guidelines and enter into MOU on the following terms and conditions:


1. The period of MOU shall be one year and can be renewed which will commence from the date of execution of this Memorandum of Understanding. The charges for granting the CRTC will be ₹ 3000/- at the time of registering CRTC and renewal charges will be ₹ 2000/- every two years. However, institutions like Medical and Nursing Colleges will be exempted from the initial registration fee but have to pay the renewal fee. If they conduct training to minimum 150 students of BCLS per year, the renewal charges will be waived off.
2. The 2nd Party, CRTC has agreed to abide to all the norms prescribed in the First party website www.cprindia.in to establish a CRT Centre with the permission of 1st Party IRCF with the required equipment and instructors. The second party shall strictly adhere to and respect all the terms and conditions of training.
3. The 2nd Party, CRTC shall extend co-operation by coordination for proper implementation of the training programme which is utmost necessary for the public interest.
4. The 1st Party shall as the facilitating agency, shall monitor and guide the 2nd Party, CRTC for ensuring its sustainability on principles of unity, self-help and mutual co-operation among them for achieving their social and health empowerment objectives.
5. The 1st Party, IRCF, may depute an observer to inspect the premises of 2nd Party and other requirements before according permission.
6. The 1st Party, IRCF, will conduct Training of Trainers (TOT) programme to train instructors, who have interest and well experienced in the field.
7. The 2nd Party, CRTC, has specifically agreed to teach only Indian Resuscitation Council guidelines which will be updated from time to time.



8. The 2nd Party, CRTC, should obtain the teaching manuals from the 1st Party, IRCF, only on paying the costs incurred thereof which will be decided from time to time. The second party, CRTC, shall not indulge in the practice of copying them by electronic or physical means.
9. The 2nd Party, CRTC, shall not mix the Resuscitation guidelines of Indian Resuscitation Council Federation with the guidelines of any other country or organization.
10. For every session of training, the 2nd Party, CRTC, shall get the permission from the 1st Party and get the training manuals, one for each candidate and conduct the training as per the norms fixed hitherto.
11. The 2nd Party, CRTC, shall have to pay of Rs.500/- for BCLS and Rs.900/- for CCLS towards the cost of material supplied which may be changed as per the cost of printing in form of manuals and the examination conducted and evaluated by 1st party per candidate they plan to train. The courier charges have to be borne by the 2nd Party for any material sent by the 1st Party to the 2nd Party. This amount will be decided from time to time.
12. The 2nd Party shall get the renewal of the training programme once in every two years on payment of prescribed renewal fee fixed by 1st Party from time to time.
13. The 2nd Party shall conduct all the necessary tests like screening of all the trainees for temperature, observing social distancing, wearing masks, using sanitizers etc., and follow all the other safety measures of COVID-19 era during the pandemic as mandated by the Govt. from time to time.
14. The 1st Party, IRCF, is not at all responsible for any mishaps or any other untoward incident or accident that may happen which amounts to injury, any other infliction or death of any individual during the said training.
15. The 2nd Party, CRTC, may have to obtain an insurance policy for the trainees during the course of the training.
16. The 2nd Party, CRTC, shall ordinarily appoint instructors and intimate the 1st Party, IRCF, about the address and details of their office and training center, the name, mobile number, e-mail id and validity of their Training certificate of the instructors for every workshop.
17. The 2nd Party, CRTC, shall not deviate from the guidelines of 1st Party, IRCF, under any circumstances.
18. The 1st Party, IRCF, shall send the observer to the 2nd Party, CRTC, for making the inspection at regular intervals.
19. The periodical inspection may be either to observe the training programme online or the observer may physically be present.




20. The 2nd Party, CRTC, shall bear all the costs of reasonable hospitality and travelling expenses by suitable means and remuneration for the observer as prescribed.
21. The 2nd Party, CRTC, shall have to purchase all the required equipment suggested by the 1st Party, IRCF, from the company of 2nd party choice under the guidance of the 1st Party, IRCF.
22. The 1st Party, IRCF shall conduct examinations for the trainees of the 2nd Party, CRTC, on completion of training programme and issue Certificate for the training undergone under their guidance, to its satisfaction. The candidates who are not successful after the examination conducted for the purpose shall have to appear for training again.
23. The 2nd Party, CRTC, has agreed to abide by all the terms and conditions fixed in toto between the 1st Party, IRCF, and 2nd Party, CRTC.
24. The 1st Party, IRCF, shall have all the rights to terminate the MOU with the 2nd Party, CRTC, at any time during the currency of the training programme without any prior notice if the 2nd Party, CRTC, violates any one of the terms and conditions here-in-after referred above.
25. The 1st party, IRCF, shall not hold any responsibility for the commissions and omissions of the certified candidates after training. The candidates have to observe and follow all the prevailing rules and Acts of Govt. of India.
26. Any disputes arising between 1st party and 2nd party can be challenged in the jurisdiction of Courts of Kakinada only.

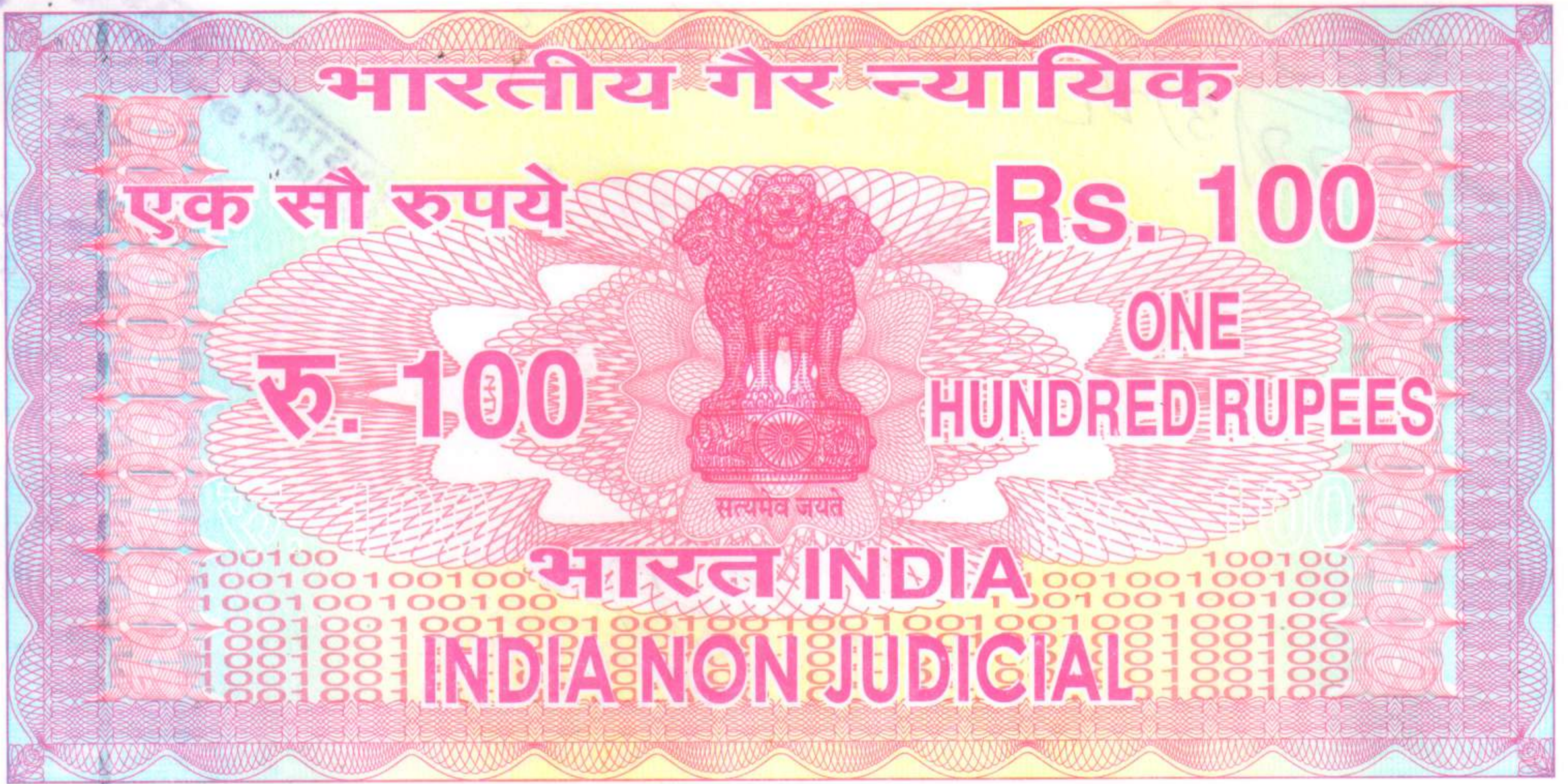

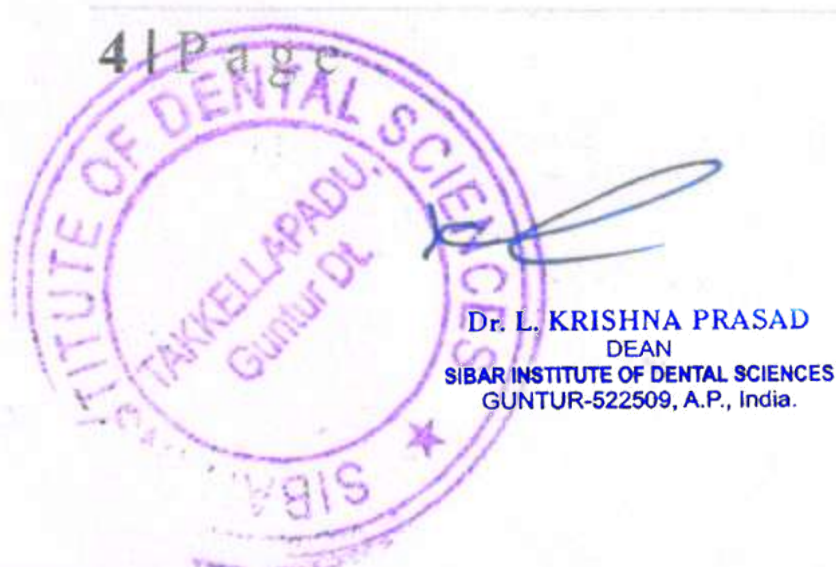


- 1.1.6. Facilitate and encourage complementar,v exchange/ seeding of startups from local region and mature ecosystem;

 - 1.1.9. Other activities mutually agreed upon by the Parties.
- 1.2. Specific terms, conditions, and procedural aspects of collaboration including financial obligations of either party in respect of each specific project/activity under this MoU shall be finalized on mutual discussion.
 - 1.3. A Four-member Steering Committee shall be constituted, being two members, each nominated by SIDS and KIIT TBI, to identify the specific areas and coordinate the collaborative activities under this MoU and finalize terms and conditions therefor.

The committee may be modified/reconstituted as per operational responsibilities.

2. Confidentiality and IPR-Protection:

2.1 Both parties hereunder agree that any information disclosed by one party to the other under this MoU shall be maintained as proprietary confidential information and that such information shall be disclosed only to the authorities as required in the



relevant statutory regulations. All such proprietary information shall be kept in confidence and the party receiving such information agrees to prevent disclosure to any other person(s) except to the personnel authorized by either of the parties on the need-to-know basis for the execution of work under this MoU.

2.2 Each party agrees that it shall not file any application seeking Intellectual Property Rights (IPR) in its own name or in the name of its associates or any other person(s), in relation to any joint activity covered or information disclosed under this MoU. However, they can seek intellectual property rights on joint names of the parties as mutually agreed on case to case basis on such terms and conditions as may be mutually agreed.

3. **Publication:**

Publications, if any, in respect of the activity under this MoU shall be in the name of personnel involved from both parties. In all publications (papers, reports, etc.,) it will be duly acknowledged that the work has been carried out by SIDS and KIIT TBI under this MoU.

4. **Non Exclusivity:**

Nothing in the terms of the Agreement shall restrict either party from having such an arrangement with any other institution.

5. **Monitoring, Reporting & Evaluation:**

Both the Institutions shall meet once in three months to monitor the report and evaluate the progress as envisaged under the MoU.


6. **Duration:**

This Memorandum of Understanding shall be valid for a **period of five years** from the date of signing of the same, and thereafter can be renewed for a further period subject to such other terms and conditions as may be mutually agreed upon by the parties hereto.



No modification to this MoU shall be binding unless it is made in writing and signed by both parties.

10. Force Majeure:

Any of the parties hereto shall not be released from its obligations for any reason except for force majeure such as war, strike, fire, acts of God, or other causes beyond the control of the parties hereto.



The first party has approached the second party for utilizing the facilities offered by various departments of SIDS for undertaking research activities.



NOW THE MEMORANDUM OF UNDERSTANDING WITNESSTH AS UNDER:

1. A joint committee comprising of designated staff members from both parties explores newer opportunities for further research in the field of dental sciences, associated dental subjects and doctoral research in subjects like Oral and Maxillofacial Surgery, Prosthodontics, Oral Implantology and so. The joint committee also decides regarding streaming of the funds for the research projects with the consent of the both parties.
2. SIDS will use all the samples and relevant information provided by the First Party for conducting research only after approval by research committee of the Second Party.
3. The information about the samples and the results are the property of the both parties.
4. The information about the samples and the results are not allowed to be transferred to any other party without the consent of both the parties.
5. All credentials arising out of the research work undertaken under this MOU are appropriately shared by both the institutes as decided by the joint committee
6. The expenditure incurred for the research work titled "Evaluation of healing of extraction socket, bone morphologic changes, primary implant stability and patient reported outcome measures with the used of E-Bone (naturally sourced nano-hydroxyapatite graft): A Randomized Control Trial" will be borne by MGDCH. 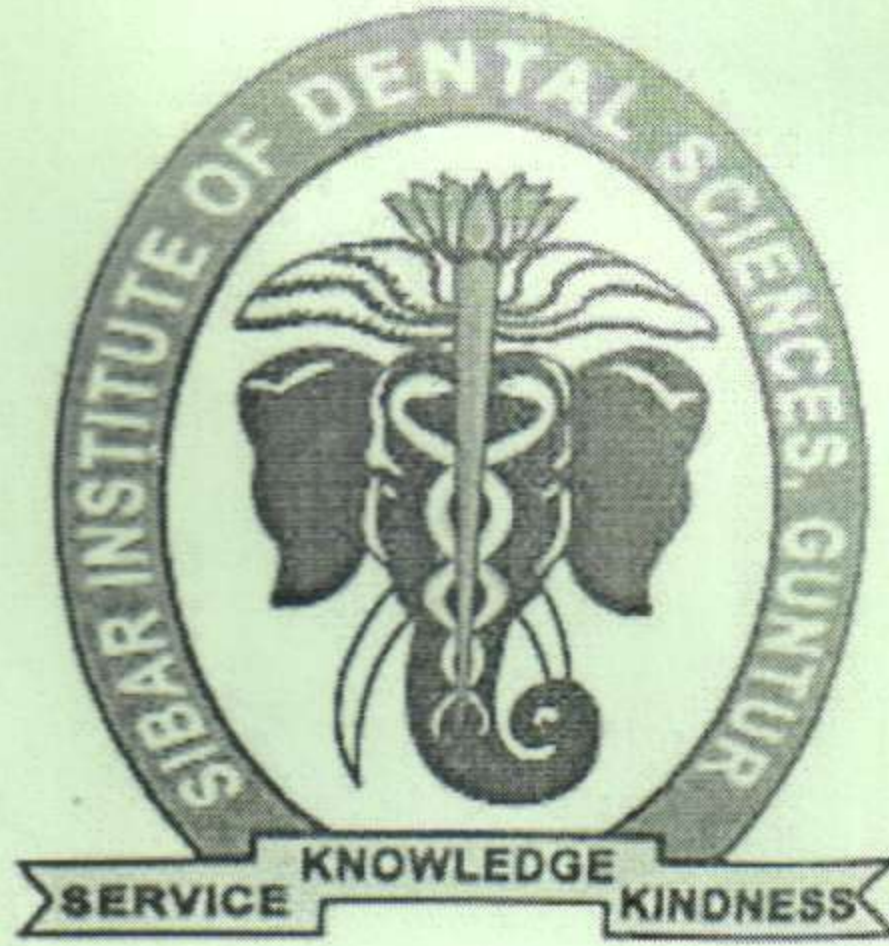



ARTICLE 2: AREAS OF COLLABORATION



The purpose of this Memorandum of Understanding (MOU) is to promote scholarly exchange and cooperation and student exchange between the Sibar Institute of Dental Sciences ("SIDS") in Guntur, India and Rutgers School of Dental Medicine, Rutgers Biomedical and Health Sciences at Rutgers, The State University of New Jersey ("Rutgers"), Newark, New Jersey, United States of America (hereafter the Parties, and singularly as the Party).

Article 2

Under this MOU, the Parties undertake to promote and provide for the exchange of scholars and professional staff, the development of cooperative efforts in research and scholarly publication, and for the exchange of students. The Parties are encouraged to explore cooperatively further avenues of interaction between the two institutions. Details of the implementation of any particular collaborative agreement shall be negotiated between the two institutions as such specific cases arise. Any such agreement will be legitimized by the completion of a specific Agreement of Cooperation.

Article 3

3.1: Faculty exchange programs or joint research projects in areas of mutual interest may be negotiated under the terms of this Agreement. Faculty participating in the program of exchange must be nominated by the sending institution and accepted by the host institution according to procedures developed internally at each institution and following a timetable to be determined mutually by the two institutions. The total number of exchanges in any one year will be determined in consultation between the two institutions.

3.2: The primary responsibility of each faculty exchangee shall be scholarly activity, including research, in collaboration with colleagues at the host institution. Unless otherwise specified, the exchangees are to have no formal classroom teaching responsibilities at the host institution.

3.3: Either Party may propose to the other specific individual research projects for collaboration. Such proposals may be made at any time and the Parties will develop an agreement for each agreed-upon project. The protection and utilization of any intellectual property arising out of a research project will be addressed in each individual project agreement.

3.4: The Parties may develop and offer joint courses (written and/or using distance technology) in teaching programs through innovative techniques and formats employed in the educational process.

3.5: The visiting scholars participating in this exchange shall be subject to the host institution's policies and regulations concerning academic personnel and intellectual property. They shall not be required, however, to comply with any such policy or regulation that is in contravention to their obligations to their home institution. In the event of a dispute, the Parties agree to work cooperatively to find a mutually satisfactory solution and to provide consistent guidance to the affected faculty member.

3.6: The host institution bears no financial responsibility for scholars visiting their institution under this Agreement, including the cost of travel between the two institutions, the cost of accommodations and food, and other personal expenses. The salary of each participant shall be paid by the sending institution during the term of the exchange.

3.7: Participants will be required to carry medical insurance equivalent to the typical policy available for visiting scholars to that country. The host institution shall bear no responsibility for any health-related expenses incurred by a visiting scholar.

3.8: Participants will be responsible for meeting all regulatory eligibility requirements and complying with all applicable customs and immigration laws and regulations for their stay at the host institution.

3.9: For each participant in this exchange, the host institution will assist in locating suitable accommodations, but does not guarantee the availability of such housing nor its proximity to the host institution's campus. Further, the host institution will provide suitable office space and access to research equipment and library materials. Where necessary, the host institution will assist in finding support for research expenses incurred by the visiting fellow during the period of residence. The host institution, however, makes no guarantees that any such support for research expenses will be available.

Article 4

4.1: Any student participating in this program must be nominated by the sending institution and accepted by the host institution in accordance with its admission procedures and regulations. The total number of participants in any one year will be determined in consultation between the two institutions.

4.2: Any reciprocal student exchange between the Parties requires a separate approval process and the signing of a more detailed Agreement of Cooperation through Rutgers Global-Study Abroad.

4.3: In addition to the conditions set forth in this MOU, any student exchange with any unit of Rutgers Biomedical and Health Sciences (RBHS) must follow all requirements contained in Attachments A, B, and C.

4.4: The period of stay for visiting students shall be determined by the two Parties. During their stay, students shall conform to the regulations of the host institution that apply to them.

4.5: The host institution bears no financial responsibility for students visiting their institution under this Agreement, including the cost of travel between the two institutions, the cost of accommodations and food, and personal expenses of the visiting student participants. Arrangements regarding the payment of tuition and fees by or on behalf of exchange and visiting students will be spelled out in the specific Agreement of Cooperation.

4.6: All participating students will be required to carry health insurance at a level equivalent to or greater than the coverage required at the host institution for international students. Students visiting Rutgers University must provide evidence of an insurance policy that is compliant with the Affordable Care Act, or purchase the Rutgers Student Insurance program available at the time of enrollment. They will be exempted from purchasing health insurance only upon providing acceptable evidence of equivalent insurance. The host institution shall bear no responsibility for any health-related expenses incurred by an exchange or visiting student.

4.7: The host institution shall assist the student in locating suitable accommodations, but does not guarantee the availability of such housing nor its proximity to the host institution's campus.

4.8: Participants will be responsible for meeting all regulatory eligibility requirements and complying with all applicable customs and immigration laws and regulations for their stay at the host institution.

Article 5

The Parties agree to encourage the development of other sorts of scholarly activities of mutual interest, including collaborative research projects, the potential participation of graduate students from the two universities in such projects, and short-term visits by faculty members from one of the institutions to the partner institution. Furthermore, when an academic event is held at either institution on a subject of mutual interest, invitations to participate, wherever reasonably possible, will be extended to faculty in related disciplines at the partner institution.

Article 6

6.1: Other than as expressly provided herein, no funds shall be exchanged between the Parties without an addendum hereto or a separate agreement enumerating the specific cost and expense related thereto.

6.2: It is jointly understood and agreed that the implementation of the above provisions will be subject to the availability of necessary funding and other resources at the Partner institution.

6.3: Both institutions subscribe to a policy of equal opportunity and will not discriminate on the basis of race, color, gender identity or expression, age, marital status, ethnicity, religion, national origin, sexual orientation, or disability, or any other category covered by law in its admission, programs, activities, or employment matters.

Article 7

The responsible coordinator for Rutgers for purposes of administering the terms of this MOU is Herminio L. Perez, Director of Student Affairs, Diversity & Inclusion. The responsible coordinator for SIDS for purposes of administering the terms of this MOU is L. Krishna Prasad, Dean. Any change in the coordinator for one Party shall be communicated in writing to the coordinator of the other Party within thirty (30) days of any such change.

Article 8

Notwithstanding any versions of this MOU which may exist in languages other than English, Rutgers shall be bound only by the provisions of this MOU as expressed above in this English version.

Article 9

This MOU is dependent upon endorsement below by the appropriate officers of the two institutions and will be effective for a period of three (3) years from the date of their signing. At the end of that period the MOU will be subject to renewal or modification by mutual written consent of the two institutions. All modifications to this MOU must be in writing and signed by both Parties, which form part of this instrument as Annex. Either Party may terminate this Agreement upon at least six (6) months written notification. Both Parties agree that all activities





Additional General Provisions and items related to Insurance and Interpretation and Designated Liaisons for all units of Rutgers Biomedical and Health Sciences (RBHS)

General Provisions

1. Each institution does hereby warrant and represent that it is fully accredited in good standing in accordance with the requirements for an institution of higher education in its home jurisdiction and also qualified by training and experience to perform the required services and programs in the manner and on the terms and conditions set forth herein.
2. The Parties herein agree that all applicable laws against discrimination, and all rules and regulations promulgated thereunder, shall be applicable to activities under this Agreement as they pertain to Rutgers and SIDS.
3. Under this Agreement, Rutgers and SIDS shall continue to be autonomous and shall be governed independently by their respective governing boards and administration except insofar as this Agreement specifically states to the contrary.
4. Neither Party shall use the other school's name or any mark likely to suggest that it is related to the other school, in any advertising, promotion or brochures without first obtaining the written consent of the other institution.
5. This Agreement shall be governed by New Jersey law and the Parties hereby submit to the exclusive jurisdiction of the State of New Jersey. However, in the event of any dispute or difference between the Parties arising in connection with this Agreement, and prior to any litigation or threat of litigation, the Parties shall, within twenty eight (28) days of a written request from the aggrieved Party to the other Party, meet in good faith in an effort to resolve the dispute.
6. Except as otherwise provided in this Agreement, the Parties hereto may not assign their rights, duties or obligations under this Agreement, either in whole or in part, without receiving the prior written consent of the other Party. Any assignment made without consent of the other Party shall be void and the non-assigning party shall not recognize any such assignment.
7. The failure of either Party to enforce a breach of any provision of this Agreement or to insist on strict performance of any provision of this Agreement shall not be construed as a waiver of the breach for the remaining period of this Agreement.

Insurance

1. Rutgers shall maintain a program of insurance throughout the term of this Agreement providing for general and professional liability coverage of Rutgers, its faculty, employees, staff and students providing services pursuant to this Agreement and providing minimum limits of coverage of \$2,000,000 per occurrence.

SIDS shall provide for general and professional liability coverage of its employees, staff and students providing services pursuant to this Agreement subject to applicable laws governing SIDS' liability.

Attachment B

Guidelines for Student Admissions and Enrollment, Student Conduct, and Student Academic Progress and Assessment for all units of Rutgers Biomedical and Health Sciences (RBHS)

1. Each Party shall inform its students about the application process and the requirements from the host institution. All students shall be matriculated in good academic standing as certified by the Associate Dean/Program Director of the student's home institution.
2. Prospective Rutgers exchange students shall apply through their respective Associate Dean/Program Director. The host institution may conduct a telephone interview as part of the selection process.
3. Each school will confirm program dates and will inform the partner institution of the dates and any changes in a timely fashion.
4. All official student records shall be maintained by the home institution but, subject to applicable law, be available for compliance with any Government regulations regarding foreign students' registration.
5. Students shall remain students of their home institution.
6. The host institution shall provide an on-site orientation program which will include information about the host institution's rules and regulations, academic standards, standards of conduct, culture, and public and personal safety matters.
7. The host institution agrees to allow utilization of its laboratories and other research facilities, if necessary, to meet the goals of the program.
8. The host institution will provide opportunities for students to interact socially and at academic gatherings with professors, professional staff, and undergraduate and graduate students, as appropriate.
9. Students in the program shall at all times follow, and be subject to, the rules and regulations established by the host institution, as well as those established by affiliated hospitals and clinical agencies, and shall do so under the specific instruction of the supervisory staff of those facilities. The affiliated clinical facilities have the right to remove any faculty member or student from the site for good cause.
10. Hearings regarding alleged violations of rules or regulations at Rutgers shall be conducted in accordance with Rutgers procedures.
11. Standards of satisfactory academic conduct shall conform to the policies and procedures of the home institution.
12. Subject to applicable law, each institution will keep the other advised of the student's status as needed or requested.
13. Student hearings regarding student professional conduct shall be conducted according to the established policies and procedures of the school responsible for overseeing the professional activities.

Each party will be entitled to receive / obligated to pay prorata funds to the other party for the activities mentioned under the MOU upto the date of termination if any agreed upon


Miscellaneous:



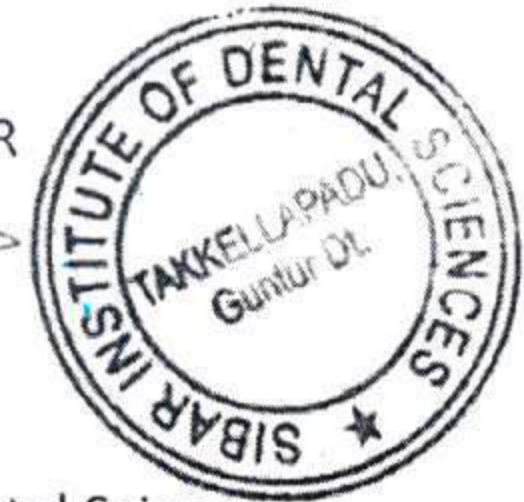

AGREEMENT for SCHOLARLY EXCHANGE and COLLABORATION

In recognition of their shared interests and as an expression of the desire to expand and strengthen the relationships developed between the two institutions, the Sibar Institute of Dental Sciences, organized and existing under, and located within, Andhra Pradesh, India (hereinafter referred to as "SIDS") makes this agreement for an academic exchange program with the STATE UNIVERSITY OF NEW YORK, an education corporation organized and existing under the laws of the State of New York, with its principal office located at State University Plaza, Albany, New York 12246, by and on behalf of State University of New York at Buffalo, School of Dental Medicine as of October, 28, 2013. The specific parameters of this exchange are set forth below.


1. Exchange of Students

The student exchange program will seek to encourage and facilitate the development of collaborative educational initiatives in areas of mutual interest.

- 1.1 The student exchange program shall be available to dental students of both universities and shall be administered by SIDS and UB, respectively.
- 1.2 The number of dental students nominated for exchange in one (1) given academic year shall be agreed to by both universities. The total number of exchange students for the initial three (3) academic year period from the home university shall not in principle exceed the number of exchange students from the host university. After the period of three (3) academic years, if the flow becomes unbalanced in one direction, the flow in that direction of the following academic years may be limited until the balance is obtained.
- 1.3 Exchange students from UB may visit SIDS for periods of one to three weeks; however, exchange students from SIDS must spend a minimum of three weeks at UB in accordance with J-1 Non-Degree Student Visa requirements.
- 1.4 Exchange candidates must have completed at least three (3) academic years of dental study at the home university prior to the exchange period, with an overall GPA of 3.0 or higher out of a 4.0 grade scale, or equivalent. While it is understood that exchange candidates nominated by the home university will normally be accepted by the host university, the host university reserves the right to review the applications of nominees and make final decisions concerning their admission.
- 1.5 Exchange participants will be nominated by the responsible office at the sending institution. The nomination will specify the dates and length of stay intended for each visitor. Nominations, including any documents required by the receiving campus, will be sent by October 15 for spring admission, and March 15 for fall semester admission, of each year. The receiving campus will inform the nominating campus of its final admission decision within thirty (30) days of receipt of said documents.
- 1.6 The host university will issue appropriate documents for the purpose of obtaining required visas in accordance with their respective applicable laws and regulations. It is the responsibility of the individual exchange student to obtain a visa in a timely manner.
- 1.7 Exchange students will be able to attend courses regularly offered at the host university,

but will not be registered as students and will not be taking courses for academic credit. Sibar students will participate in clinical experiences through observation only. UB students may be permitted to provide direct patient care under the direct supervision of Sibar clinical faculty.

- 1.8 Exchange students must satisfy the language proficiency requirements of the specific dental program at the host university. Normally, SIDS exchange students will be required to have a minimum TOEFL of 500 (iBT of 79) to participate in the program.
- 1.9 Exchange students will pay normal tuition to their home university in accordance with the policies of that university. The host university will not make charges upon the home university or the exchange students for tuition or application fees.
- 1.10 Exchange students will be responsible for making their international travel arrangements and shall bear all associated costs, including but not limited to, room; board, study materials, local transportation, health insurance and medical care, university user fees, personal expenses, and passport/visa application fees.
- 1.11 The host university will assist students in finding suitable accommodation. Exchange students may be housed in residence halls or appropriate university accommodations if applications are received for such accommodation in advance. Housing costs are the responsibility of the exchange student.
- 1.12 The host university will make every effort to facilitate integration of exchange students into the student life of the host university.
- 1.13 Exchange students shall be subject to the rules and regulations of the host university. Each university reserves the right to dismiss any exchange student at any time for conduct in violation of its established rules and regulations. Every effort will be exercised to consult with appropriate officials of the sending institution prior to any sanction or disciplinary action. However, the dismissal of an exchange student shall not adversely affect the arrangements regarding other exchange students.
- 1.14 In the event that an exchange participant is involved in a serious accident or other circumstance of a grave nature, or is subject to disciplinary action, the host university will immediately notify the sending institution. If necessary, the immediate notification of said incidents or actions may be limited to a statement of the problem and a brief outline of intended plans of action. Detailed information should be forwarded to the home institution in a timely manner.
- 1.15 Upon completion of the program at the host university, exchange students are required to return to the home university. No extension of stay will be authorized unless otherwise specifically agreed upon by both universities.

2. Exchange of Faculty

The faculty exchange program will seek to encourage and facilitate the development of collaborative research and educational initiatives in areas of mutual interest.

- 2.1 SIDS and UB will consider each request for exchange of faculty on an individual basis.
- 2.2 Exchange participants will be nominated by the responsible office at the sending institution. The nomination will specify the dates and length of stay intended for each visitor and will outline the proposed program and objectives. Each institution will establish dates for receipt of nominations for prospective exchange faculty.
- 2.3 Travel arrangements and the cost of travel for exchange participants are the responsibility of the individual participant.
- 2.4 The host institution will assist exchange participants in finding suitable accommodations.
- 2.5 Exchange participants will be granted access without charge to library materials necessary for academic endeavors as well as archives and laboratories required to conduct research.
- 2.6 Salary support of exchange faculty is the responsibility of the sending institution.
- 2.7 Exchange faculty must carry comprehensive health insurance valid in the host country. The host institution will assist exchange faculty in obtaining coverage when necessary.
- 2.8 Each institution will provide appropriate certificates of eligibility for visas and other documentation as required by government agencies in the host country.
- 2.9 SIDS and UB welcome the families of exchange faculty. Faculty traveling with spouses and family must be responsible for any additional expenses incurred. Each institution will prepare an estimate of the additional costs for dependents.
- 2.10 Exchange faculty who wish to remain at SIDS or UB beyond the exchange period must receive endorsement of both the sending and host institutions. Any stipend or remuneration received for program extensions must come from sources other than those designated for this exchange.
- 2.11 Both SIDS and UB will, from time to time, welcome faculty for affiliation independent of the exchange. While the exchange committee at each institution may aid in facilitating introductions, matters involving affiliation, travel, and stipend will be arranged separately from exchange sources and protocols.

3. Other Considerations

- 3.1 In addition to the faculty exchange, SIDS and UB will seek ways to promote and support collaborative research through joint conferences and workshops, joint publications, and exchanges of scholarly materials.
- 3.2 SIDS and UB will encourage other collaborative ventures to be agreed upon from time to

time, designed to deepen the relationship between the two universities.

- 3.3 This Agreement is based on reciprocity and the two universities will do their utmost to ensure that an equal number of participants are exchanged over the life of this agreement.
- 3.4 Each university will designate an office and officers for general program administration. Officers will be in regular contact with one another, especially with regard to exchange details necessary to implement this agreement.

4. Term of Agreement and Renewal

This Agreement shall remain in force for a period of five (5) years, after which it shall continue unless either party expresses in writing its intention to change or to terminate it. Either party can terminate the agreement by giving (90) days notice in writing to the other. Both institutions agree to review the agreement every five years to determine if amendments are necessary. In the event of major revision or cancellation of this Agreement, the receiving university will provide current participants with the opportunity to complete their approved program.

In Witness Hereof, the duly authorized representative of each university agrees to the provisions of this document.


