

RULES OF CONDUCT FOR STUDENTS

Students should possess the college identity card within the campus. Discipline should be absolutely maintained inside the campus.

Ragging in any form is strictly prohibited. Those indulge in ragging will be dismissed from the college and handed over to the police as per rules.

Percentage of attendance is compulsory for the theory, clinical and practical classes. Students with less than 75% attendance will be detained from appearing for the University examinations.

Indiscipline, misbehavior or gross insubordination, and any violation of college rules and regulations will lead to a fine, suspension or dismissal of the student from the college.

Any derogatory action or misconduct by a student, outside the college campus that is likely to mark the reputation of the institution will be viewed seriously and liable for punishment according to the nature and seriousness of the offence.

A specified uniform (dress code) is compulsory for the students. Strict dress code should be maintained by the student inside the campus, with white apron is a must. Jeans, casuals, and sports shoes are not allowed in the departments and clinics. Students are expected to keep the college campus neat and clean. Writing on the walls, desks, and damaging the college property is prohibited.

Use of cellphones inside the college campus during the working hours is strictly prohibited. A fine of Rs. 500/- will be levied at the first instance. If it is repeated the cell phone will be confiscated.

Any damage or loss caused to the college property will be recovered from the concerned student. The student should be polite and courteous to the teaching and office staff and to the patients. They should not use indecent language with the fellow students or the staff. Smoking, or use of alcohol and addictive substances is strictly prohibited inside the campus.



LIBRARY RULES

- 1. The library is kept open on all working days from 9-00 a.m. to 9-00 p.m.
- 2. The library has more than 3000 books and 70 journals subscribed annually. The Library is equipped with a fully automated Xerox Machine, which facilitates the requirements of the students. In addition, there is an audiovisual hall with collection of over 300 CDs. There are 20 Computers with CD drive and Internet Connection.
- 3. All students and teaching staff are members of the library.
- 4. Books will be lent to the members only against library card.
- 5. Books issued from library should be returned within one week.
- 6. Borrowers are responsible for the loss or damage of the books borrowed. The date slip / barcode and number label should not be tampered with.
- 7. Every book will be examined when it is returned and if any book is found to be marked, soiled, or damaged, the borrower shall be required to replace the book with a new copy or pay the cost of the book.
- 8. If the books are not returned to the library on the due date, a fine of Rs. 10/- per book per day shall be levied. Absence from the college shall not be an excuse for any delay in returning the books. Books due on a holiday may be returned on the next working day.
- 9. Reference books, journals, CD's, and copies of University examination question papers will be given only for reference.
- 10. The librarian may recall any book at any time in case of verification of stocks and during inspection days.
- 11. Students are prohibited from taking their aprons, bags and other personal belongings with them inside the library.
- 12. Cell phones are not permitted inside the library. Absolute silence should be maintained inside the library.
- 13. Members may suggest in writing to the librarian about the purchase of textbooks or reference books that are not available in the library or for which additional copies are required.





HOSTEL RULES & REGULATIONS

- A responsible person either parent or guardian who will comply with the formalities and procedures of admitting/vacating the hostel, must accompany candidates seeking admission for hostel accommodation. No inmate will be allowed to vacate the hostel in the middle of the academic year.
- 2. No student will be allowed in the hostel without formal admission.
- 3. The inmates of the hostel should not normally stay in the hostel during the college working hours. In case of a valid reason to stay in the permissises, they can do so with, permission of resident warden / chief warden.
- 4. Inmates of the hostel are allowed outings on 2nd Saturday and 4th Sunday. They should be back by 8-00 p.m. The resident warden concerned will take roll call at the specified time.
- 5. Strict silence should be observed between 7-00 p.m. and 7-00 a.m.
- 6. Leave from the hostel premises will be granted only on application of leave in the prescribed format.
- 7. The inmates are expected not to damage any hostel property. The cost of damages caused in the room or in the premises will have to be borne by the inmates concerned / a fine will be levied.
- 8. **Ragging** in any form is strictly prohibited and severe action will be taken against those who include in such activities.
- 9. Inmates should not involve in any undesirable activities (such as smoking, drinking, gambling, writing on walls / doors, etc.,) within the hostel campus.
- 10. Once a student joins the, he / she be deemed to have become a continuous member of the mess till he / she vacates the hostel.
- 11. Students who are absent on the re-opening day will be deemed to have joined the mess on that day and will be charged accordingly.





12. The inmates must strictly adhere to the following timings of the mess

Breakfast: 07-30 - 9-00 a.m.

Lunch: 12-30 - 2-00 p.m.

Snacks: 04-30 - 5-30 p.m.

Dinner: 07-30 - 9-00 p.m.

- 13. Food will not be served in rooms. Inmates are not allowed to take food in their rooms.
- 14. If an inmate is ill, the resident warden will make suitable arrangements to take care of the inmate.
- 15. Day scholars are not allowed to stay in the hostel.
- Strict discipline in the dining hall should be maintained and food is not to be wasted.
- 17. Mess reduction is not admissible to the inmates even on holidays.
- 18. Electrical switches must be put off, when not required / while going out of the room. If found switched "on" a fine of Rs. 100/- will be levied per day of misuse. Electric water heater, refrigerator, TV, or stove should not be used inside the room.
- 19. Students are advised not to keep valuables / cash in the hostel room. Prosthetic works inside the hostel rooms are strictly prohibited. If anybody is found doing such work, a fine of Rs. 1000/- will be levied.
- 20. Each student should see that the room occupied by her/him is neat and clean.
- 21. A student who once reserves, his / her room by paying the fee for hostel accommodation, will not be eligible for refund if he / she chooses not to stay in the hostel till the completion of the course.



ANTIRAGGING MEASURES

RAGGING in any form is strictly prohibited in side and outside the college. Ragging means doing an act which causes or is likely to cause insult or annoyance of fear or apprehension or threat or intimidation or outrage of modesty or injury to a student. Ragging is a disorderly conduct by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which case or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

The application for admission into the dental college has a printed undertaking to be filled up by the candidate and the parent / guardian of the candidate and the nature of the punishment if indulged in Ragging. This undertaking is to be signed by the senior students also. To prevent Ragging, Vigilance and Anti ragging committees have been constituted with their contact phone numbers. Grievance boxes are kept in prominent places of the college. If necessary the ragging incidents are reported to the police and F.I.R. would be filed. A close watch is kept on the visit of non-students / strangers to the college campus and college hostels.

PROHIBITION OF RAGGING IN EDUCATIONAL INSTITUTIONS ACT 26 OF 1997

1. SALIENT FEATURES:

- 1. Ragging within or outside any Educational Institution is prohibited.
- 2. Ragging means doing an Act which causes or is likely to cause insult or annoyance or fear or apprehension or threat or intimidation or outrage of modesty or injury to a student.

	NATURE OF RAGGING	NATURE OF PUNISHMENT
1.	Teasing, embarassing and humiliating	Imprisonment upto 6months or fine upto Rs. 1000/- or both.
2.	Assaulting or using criminal force or criminal intimidation	Imprisonment upto 1 year or fine upto Rs. 2000/- or both.
3.	Wrongfully restraining or confining or causing hurt	Imprisonment upto 2 years or fine upto Rs. 5000/- or both
4.	Causing grievous hurt, kidnapping or rape or committing unnatural offence	Imprisonment upto 5 years or fine upto Rs. 10,000/

NOTE:

- 1. A student convicted of any of the above offences, will be expelled from the college.
- 2. A student imprisoned for more than six months for any of the above of fences will not be admitted in any other college.
- 3. A student against whom there is prima facie evidence of Ragging in any from will be suspended from the college immediately.

The following Anti-ragging measures are implemented in Sibar Institute of Dental Scinences.

Sibar Institute of Dental Sciences received the copy of the order dated 11-02-2009 passed by the Hon'ble Supreme Court of India in Civil Appeal No. 887/2009 for our perusal and complied the direction contained therein including para 27 with strict implementation and enforcement. Also the instructions by University Grants Commission are also implemented.

The following anti-ragging measures are implemented in our colleges:

- Anti-ragging committee and vigilance (Anti-ragging) Squad which include staff, and students including girls have been constituted. The parents of the students are also included. Their contact phone numbers including of principal are displayed in the college common rooms, class rooms, library, hostels, mess, in each room of the hostels and in notice boards. Regular and surprise visits of Anti-ragging committee and squad are done both in the college & hostels.
- 2. Full time wardens are working in boys & girls hostels and oversee the prevention of ragging in any form in the hostels. In the hostels, separate block is allotted for fresh students so as to minimize the mingling with the senior students.
- 3. Counselling of senior batches of students done by senior faculty with the nature of punishment for each act of ragging.
- 4. Identify the raggers in the institution.
- 5. Measures against raggers are displayed in the campus.
- 6. Concerted action to be proposed against the culprits (raggers)
- 7. To involve the media and civil societies in the exercise.
- 8. Yoga and Meditation classes to the senior & juniors are conducted, so that they become more "Satwik" in their approach. Already conducted basic course in "Art of Living & Sudarshan Kriya" and the results are excellent.



- 9. The banners of punishment deterrent to the raggers are displayed at the entrance of college and hospital, all the nine departments (clinical and non-clinical), all the lecture halls, Library and hostels in the campus for the boys and girls.
- 10. Form of undertaking by each and every student and their parents informing them of the punishment for ragging have been taken.
- 11. Distributing pamphlets which are having the information of punishment of ragging.
- 12. Conducting meeting among seniors and explaining about the problems of ragging and trying to prepare them against ragging.
- 13. In college hours regular supervision by anti-ragging committee members, faculty and ministerial staff in the campus.
- 14. Wardens in the hostels keep an eye on senior students and warning them against ragging.
- 15. Consultant psychiatrist is appointed to give counselling to deal with psychological aspects of ragging.
- 16. The Government of India started a toll free anti-ragging help line to work around the clock No. 1800-180-5522 and it works as a deterrent to an act of ragging.
- 17. Mentors or counsellors: Twenty doctors are selected from the teaching staff and each is given five freshers and they are the counsellors through out BDS Course and counseling the students regarding -ragging; health problems and academic progress and maintain the record of each student.
- 18. C.C.T.V.s are arranged at vulnerable points to keep an watch of ragging incidents.
- 19. Freshers day is being organized as early as possible to stop the menace of ragging.

USEFUL INFORMATION ON ACADEMIC ISSUES RELATED TO BDS AND MDS PROGRAMMES

BACHELOR OF DENTAL SURGERY (BDS)

As per Dental Council of India revised BDS Course regulations 2007 salient features of study are given below:

- **a. Duration:** The under graduate Dental training programme leading to BDS degree shall be of 4 years duration with 240 teaching days each academic year. The students shall be required to have been engaged in full time study in a dental college recognized / approved by the Dental Council of India.
- **b. Internship:** After passing the Final Examinations all the students should complete one year rotatory Internship.
- **c. Migration**: In exceptional cases migration from one Dental College to another may be considered by the Dental Council of India subject to fulfillment of laid down conditions.
- **d. Attendance requirement, progress & conduct :** 75% in Theory and 75% in Practical / Clinical every year.
- **e. Examinations and Evaluations :** Evaluation is achieved in a continuing process as follows :
 - i) Formulative or Internal Assessment.
 - ii) Summative or University Examinations.
- f. Methods of Evaluation:
 - i) Written Test
- ii) Practicals
- iii) Clinical examination
- iv) Viva Voce
- **g.** Internal Assessment Examination: The countinuing assessment examinations will be held at least 3 times in year and average of the marks obtained will be considered.
- **Schedule of Examination :** BDS Examinations by Dr. NTR University of Health Sciences will be conducted at the end of 1 year, Ilyear, Illyear and IV year. Candidates satisfying the requirements of attendance and other laid down conditions will only be allowed to appear for the examinations. Students who do not clear all subjects of IBDS Examinations within 3 years from the date of admission are



discharged from the course. Subjects of university examinations yearwise are as given below:

IBDS Examinations:

- i. General Anatomy including Embryology and Histology
- ii. General Human Physiology and Biochemistry
- iii. Dental Anatomy, Embryology and Oral Histology.

II BDS Examinations : Students who have successfully completed the Ist BDS examinations can only appear for IInd BDS examinations.

- i. General Pathology and Microbiology
- ii. General and Dental Pharmacology and therapeutics
- iii. Dental Materials
- iv. Pre Clinical Conservative Dentistry only Practical & Viva Voce.
- v. Preclinical Prosthodontics only practical & Viva Voce.

III BDS Examinations: Students who have successfully completed the IInd BDS examinations can only appear for IIIrd BDS examinations.

i. General Medicine

- ii. General Surgery
- iii. Oral Pathology and Microbiology

IV BDS Examinations: Students who have successfully completed the IIIrd BDS examinations can only appear for IVth BDS examinations.

- i. Oral Medicine & Radiology
- ii. Pedodontics & Preventive Dentistry
- iii. Orthodontics & Dento Facial Orthopedics
- iv. Periodontology
- v. Prosthodontics and Crown & Bridge
- vi. Conservative Dentistry and Endodontics
- vii. Oral and Maxillofacial Surgery
- viii. Public Health Dentistry

Written Examinations in each subject consist of one paper of 3 hours duration with maximum marks of 70 each. Subjects of Physiology & Biochemistry and Pathology & Microbiology will be divided into 2 parts



A & B of equal marks. The question papers contain different types of questions like essay, short answers and objective type / M.C.Q.S.

Practical and Viva Voce in University Examinations will be conducted on completion of Theory written examinations as per Programme scheduled by Dr. NTR University of Health Sciences, Vijayawada.

Marks allocation in the practical and viva voce, university examinations in the subjects of Pre-Clinical Prosthodontics and Pre-Clinical Conservative Dentistry is as follows

MASTER OF DENTAL SURGERY (MDS) GOALS & OBJECTIVES OF THE CURRICULUM

The goals of Postgraduate training in various specialities is to train BDS graduates to :

- a. Practice respective speciality effectively and efficiently backed by scientific knowledge and skills.
- b. Exercise empathy and luring attitude and maintain high ethical standards.
- c. Continue to evince keen interest in continuing professional education in the speciality and the allied specialities irrespective of whether in teaching or practicing.
- d. Willing to share the knowledge and skills with any learner, junior or colleague.
- e. To develop the faculty for vertical analysis and evaluation of various concepts and views, to adopt the most rational approach. By the time the candidate completes the course the objectives that are to be acquired are:
- a. Knowledge (Cognitive domain)
- b. Skills (psycho motor domain)
- c. Human values, ethical practice and enhancement of communication skills.

Definitions of Various Specialities:

- 1. Prosthodontics and Crown & Bridge: Prosthodontics and Crown & Bridge and oral implantology is that branch of dental science pertaining to the restoration and maintainance of oral function, health, comfort and appearance by the replacement of missed or lost natural teeth and associated tissues either by fixed or removable artificial substitutes.
- **2. Periodontology:** Periodontology and Oral Implantology is the science dealing with the health and diseases of the investing and supporting structures of the teeth and oral mucous membrance.
- 3. Oral & Maxillofacial Surgery: Oral and Maxillofacial Surgery



and Implantology deals with the diagnosis and surgical and adjunctive treatment of diseases, injuries and defects of the human jaws and associated oral and facial structures.

- **4. Conservative Dentistry and Endodontics:** Conservative dentistry deals with prevention and treatment of the diseases and injuries of the hard tissues and the pulp of the tooth and associated periapical lesions.
- **5. Orthodontics and Dentofacial Orthopedics**: Deals with prevention and correction of oral anomalies and malocclusion and the harmonizing of the structures involved, so that the dental mechanisms will function in a normal way.
- **6. Oral Pathology & Microbiology:** Oral Pathology deals with the nature of oral diseases, their causes, processes and effect. It relates the clinical manifestation of oral diseases to the physiology and anatomic change associated with these diseases.
- **7. Public Health Dentistry:** Community Dentistry is the science and art of preventing and controlling dental diseases and promoting dental health through organized community efforts.
- **8. Pedodontics and Preventive Dentistry:** Deals with prevention and treatment of oral and dental ailments that may occur during childhood.
- **9. Oral Medicine & Radiology :** Oral Medicine is that speciality of dentistry concerned with the basic diagnostic procedures and techniques useful in recognizing the diseases of the oral tissues of local and constitutional origin and their medical management.

Radiology is a science dealing with X-Rays and their uses in diagnosis and treatment of diseases in relation to orofacial diseases.

Teaching and learning Activities:

All the students registered for MDS course in various specialities have to pursue the course for 3 years as full time students. The students are to take part in various teaching activities designed by the institution & university and implemented through the various processes as illustrated below:

- a. Lectures
- b. Journal reviews
